MINUTES OF THE MEETING HELD ON MONDAY 8th JULY 2024 IN THE PARISH HALL COMMENCING AT 7.30 p.m.

0. PUBLIC PARTICIPATION TIME. There were no parishioners present at this stage.

1. APOLOGIES - apologies were received Mr. S. Harris and Mr. G. Butler

2. DECLARATIONS OF INTEREST. Mrs J. Rowley advised an interest in Item 6 and took no part in the discussion or voting.

3. MINUTES OF THE JULY MEETING were taken as read and unanimously approved by all present at that meeting and signed after being proposed and seconded.

4. MATTERS ARISING.

1. HIGHWAY MATTERS – FMS Updates – 1. Bus Stopping at Button Oak – Awaiting update.2. Roadside Gully Cleaning – Some work carried out – not complete. 3. Meaton Lane Potholes - A number had been marked – not completed. 4. Problems Catsley to Lewis Garage – Not carried out but edge of highway marked– being chased. 5. Work advised as completed – Pothole by Fairview Lodge/Pothole Cloggs Bank/Potholes by Sturt Lane and Halls Farm.

<u>Other Highway Matters.</u> **6.Bus Pull-In at Kinlet** – Still endeavouring to obtain point of contact at S.C. A plan of suggested remedy would be sent. CCTV covering this site confirmed as registered with ICO. **7. Lengthsman Update** – Awaited.

<u>Other General Matters Arising.</u> **8.** Mr.Shepherd reported on the recent Area Meeting and advised that S.A.L.C. would be taking up with S.C. badly signed diversions and we would obtain more details relating to the new honours scheme re people who had made a extra contribution towards the Parish. **9.** Beechwoods Tenancy – now confirmed on website as requested. **10.** Fly Tipping – now cleared.
